(WITHOUT AID) W.E.P. MEMORISED SESSION 1982-83.

Sir,

With reference to your application on the subject noted above, it is directed to convey the approval of Director of Education, Delhi to grant recognition to your school from class Ist to VIII (without aid) W.E.P. 1-4-1982 subject to the fulfilment of the following terms and conditions:-

1. That the school shall abide by the provisions of Delhi School Education Act and Rules, 1973 framed thereunder as well as the students issued from time to time.
2. That the school shall admit students without any discrimination of caste and creed and preference shall be given to the students of Rohtak area.
3. That the provisions of section 10(i) of DSEA, 73 shall be fulfilled.
4. That adequate sports material shall be purchased and made available to the students immediately.
5. That the school shall strictly abide by the provisions of Delhi School Education Act and Rules, 1973 and payment shall be made as per section 10(i) of DSEA, 1973 and to all employees.
6. That the enrolment in each section shall not exceed the number of students calculated @ 12sq.ft. per students for the available floor area of the class room and the school shall provide adequate and sufficient accommodation as per the norms of the Directorate of Education, Delhi in each class. Number of the existing sections should not exceed the number of the class-room of proper size in the school.

- 7. That the school shall dispense with the services of unqualified and over-aged staff, if any immediately.
- 8. That all the facilities prescribed under Rules 30 and 51 of the DSEA, 1973 shall be made available to the students provision of Rules 6,7 and 8 be strictly observed.
- 9. That the arrangement of good drinking water shall be made available to all the student as well as the teachers.
- 10. That the violation of any instructions/orders/conditions/ rules and regulations of the department shall lead to the withdrawal of recognition of the school.
- 11. That the class IX shall not be opened without the prior approval of the Director of Education, Delhi.

Sir,

With reference to your application on the subject cited above, I am directed to convey the permission of the Director of Education, Delhi to your society to establish a new school from class Ist to VIII (without aid) in Zone No. 5 Dist.-North in I Block Ashok Vihar, Delhi-52 subject to the following conditions:-

1. That the provision of DSEA/P, 1973 and rules framed there under shall be observed by the society.
2. That the management of the school will fulfill all the conditions laid down under rule 50 and will provide all the facilities given in rule 51 of DGER, 1973 to the Instt.
3. That the management of the school will get the scheme of management approved from the department immediately.
4. That only qualified and trained teachers will be appointed, Govt. scales alongwith all allowances will be paid to the teaching and non-teaching staff through crossed cheque.
5. That the management of the school will not ask for grant-in-aid from the department.
6. That the school will not run for the profit of any individual association or group of persons.
7. That in case at any time the management of the school is unable to run the school movable and non-moveable property of the school will be transferred in the name of Director of Education, Delhi.
8. That all the recognised classes shall be run at one place only.
9. That the management of the school will apply for grant of recognition of the school under DSEA/R, 1973 and recognition will not be granted unless statutory provisions of section 4(A) (a) to (f) read with rules 50&51 are fulfilled.
10. That the school shall be run under the control of Montessori Education Society, Delhi and suitable funds will be made available for the construction of suitable building on the land allotted to the society as declared as per the specifications of the Deptt. with a period of three years.

11. That the management of the school will obtain land from DDA in the name of the society through Directorate of Education, Delhi and shall construct a school building thereon for the proposed school as per the specifications of the department.
12. That adequate and sufficient accommodation of 12 sq.ft. per student shall be provided for class-room. The normal size of class-room will be 24' x 20'. No other activities other than education shall be run.

If recognition for the proposed school is not sought after fulfilling all the above conditions within a period of three years, this permission for a new school shall be treated as cancelled.

Sir,

with reference to your application on the subject cited above,
I am directed to convey the approval of the Director of Education,
Delhi for the upgradation of the existing middle school to Secondary
level without aid w.e.f. 1996-97 session to the fulfilment of the
following terms and conditions:-

1. That the school shall abide by the provisions of DSEA & R, 73 framed there under as well as the instructions issued from time to time.
2. That the school shall admit students without any discrimination of caste & creed.
3. That the school shall meet the additional liability of Secondary classes.
4. That a proper library shall be established and facilities for reading room shall also be made available for students as well as teachers. Books as per the ratio of 10 books per student shall be purchased and made available to the students.
5. That adequate sports material shall be purchased and made available to the students.
6. That the school shall strictly abide by the provisions of section 10 (i) of the DSEA & R, 73.
7. That the school shall not run any unrecognised classes or any other activities within the school premises and all the recognised classes shall be run at one place.
8. That the school shall submit the returns to the Act Branch of the Directorate of Education as per rule 180 (i) of DSEA & R, 1973.
9. Fresh health certificate from MCD be obtained and produced to E.O. for verification.
10. That the school shall dispense with the services of unqualified and over-aged staff, if any immediately.
11. The managing committee of the school shall not increase fee in future during academic session without prior approval of Director of Education which is a mandatory requirement under sub-section (3) of section 17 DSEA & R-73.

12. That all the facilities prescribed under rule 50 & 51 of the DSEA & R, 1973 shall be made available to the students.
13. Proof to the effect that qualified staff has been appointed as per RPs be provided for the verification of E.O.
14. That the arrangements for good drinking water shall be made available to all the students as well as to the teachers and sanitary facilities shall also be provided to the students adequately. Health certificate may be obtained from the local body within a month.
15. That the school shall comply with the norms of the CBSE for affiliation for examination purposes.
16. Medical facilities leave L.C bonus, teaching allowances, CPF etc. be paid since recognised of the school.
17. Provident fund register be maintained and cash book to be completed and shown to E.O. of the zone concerned for certification from time to time.
18. That the violation of any instructions/conditions/rules and regulation of the department shall lead to the withdrawal of recognition of the school.
19. That report about the fulfilment of the above conditions shall be send to the E.O. every six month.
20. That the school shall equipment of science labs as per the norm of the department and suitable facilities for practical work shall be provided to the students.
